## MANITOBA EDUCATION PROPERTY TAX CREDIT

To be eligible for the Manitoba Education Property Tax Credit Advance you must be able to check off all the provincial requirements (#3). Any application forms submitted prior to the tax bills being printed, are eligible to receive the MEPTCA Credit on your current year's tax statement. If submitted after, the current year's tax credit can be claimed through Income Tax and the credit will appear the following year on the tax statement.
