Delegation 4:35 p.m. Orest Christiuk - Dufrost Water Supply

Orest came to update council on the Dufrost Water Supply's (DWS) latest information on their work to relieve the municipality's responsibility with the well. The members of the DWS requests to keep the manner of operating status quo until they receive more information from outside partners. They are currently having discussions with the Ste. Elizabeth Water Co-op to possibly tap into their line and become members. DWS also has been in discussions with the Office of Drinking Water for other possibilities such as: 1. operating as an individual potable water co-op (expensive), 2. operating as an individual non-potable water co-op (affordable) 3. operating as an individual semi-public water system by the co-op (moderately expensive). It has been determined by the residents that the option of converting this DWS into a Local Improvement District managed by the municipality is completely out (extremely expensive). Council is tabulating stats on who is currently utilizing our 3 municipal wells and will review this after July 1st.

Delegation 5:00 p.m. Reynald Lambert – RBL Landscaping

Reynald is interested in working on the municipality's water and sewer infrastructure (new installation and repairs) for the St. Malo and Otterburne Utilities and requests council to consider accepting his company as an approved contractor. Council will delegate the St. Malo Utility committee to bring forth recommendations on the request.

Application: C2-2010-70200

Applicant: Marc Marion, Marc Maynard, Lucien Picton for St. Malo Golf and Cabins

Proposal: To permit the expansion of their operation to allow an additional 125 recreational campground sites

to their current 25 sites. These sites will be constructed where the current driving range is situated.

Area Affected: 5-5-16161, 128 East Lakeshore Road

CAO confirms he has received one email of concern from Neil Loughran and Josette Lukowycz, and it is read.

Email from Loughran/Lulowycz – As residents at 23 East Lakeshore Road, their concerns with the application are -the possible increase in pedestrian, cyclists and ATV traffic on East Lakeshore Road.

- -the current condition of East Lakeshore Road and the possible worsening of the conditions with the increased traffic.
- -the increased "scenic" traffic and requests signage to be posted to discourage recreational-only traffic further on East Lakeshore Road.
- -the increased use of the East Lakeshore landing/water access where upgrades are required to sustain it.

Don Toupin – Cottage owner on Lakeshore Drive, has concerns with the possible spill over activity that may come from the increasing number of seasonal campers such as pedestrians, cyclist or canoeist traffic coming to and from Lakeview Road to the already overused boat landing. He wishes to see this type of traffic diverted to another, improved lake access.

Tim Sawatzky – Home owner on RI-EU Street – Questioned the number of lots and its configuration as proposed on the concept plan. He is concerned with headlights shining in his home, dust control, unsightly sight lines as he notices the current campground's wood piles and fuel tanks on a daily basis. He would like to see a real solid wooden fence installed as per the last CU orders, not the cedar fence currently installed, and have run the entire length of the frontage on Lakeshore Drive. Tim would like to see absolutely no traffic to and from the clubhouse on Lakeshore Drive because he's observed that the private gate behind the clubhouse gate is often left open by the employees. He wishes to have the trees required in the previous CU Orders planted, or have council remove that condition from the CU Orders by resolution if they intend on not enforcing it. Tim feels that this project is not compatible with the neighbourhood and has concerns with the clubhouse parking lot encroaching on the Lakeshore Drive road allowance.

Proponents - Marc Maynard/Marc Marion/Lucien Picton — The proponents confirm that the only access to the facilities will be from East Lakeshore Road. The entry from the Lakeshore Drive is only for employees delivering supplies from Marc Marion's residence. They confirm that they will try to encourage pedestrian traffic walking to the lake to utilize the East Lakeshore Road and Bear Drive lake landings as approved by the LUD. Their project will initially start with 25 sites and will expand to another 100 sites later as the demand increases. The map that was presented to council is a concept plan and is subject to modifications. They confirm that they have intentions on putting up the remaining fence this year, acknowledged that the trees were planted, but did not survive.

Public Hearing adjourned at 8:45 p.m. and Council calls a 5 minute break.
