Whereas the developer of the Upstream Development had agreed and signed the Development Agreement for C.P.S. File No. 4119-2004-4027, dated November 21, 2005, to set the development standards and conditions for this subdivision;

Whereas the municipality allowed the developer to sell his lots prior to the development's road being completed up to Municipal Standards in 2006;

Whereas the municipality had provided the developer with a letter and a list of the development's infrastructure deficiencies on September 28, 2007;

Whereas the developer had not complied with the conditions of Resolution No. 214-08's deficiency list duly notified by registered letter on April 25, 2008 and Resolution No. 03-09 by registered letter sent on January 20, 2009 where the municipality informed the developer of the required gravel had to be applied by July 1st;

Whereas council is concerned that the new lot owners may be at a safety risk in developing dwellings in the subdivision where fire and ambulance vehicles may have trouble passing in wet conditions due to the fact the road has yet to be completed to Municipal Standards;

Whereas council feels that they have given the developer more than ample time to resolve the deficiencies;

Be it resolved that council hereby approve the hiring of a contractor to apply 2" of gravel to the entire Upstream Development (Upstream Crescent and East Lakeshore Road) to have his development meet the required minimum municipal standards;

Further that the invoices be forwarded to Mr. Etienne Hebert for payment;

And further that if the invoices are not paid within 3 months of issuance that the municipality takes necessary action to recoup the costs that it had to incur to bring the development's road to a safe standard.
