## Delegation 5:30 p.m. Mayor Real Cure and Deputy Mayor Denis Fillion – Village of St. Pierre-Jolys

Village came to council and confirms the \$50 per metric tonne tipping fee for the privilege to dispose of the Village residents' garbage in the De Salaberry Landfill. They would like to see council consider allowing their residents to dispose their garbage at the gate at the same tipping fee rate as the De Salaberry municipal residents for the balance of 2010 since they are handing over partially funded landfill assets such as the Eco-Centre. They request that the municipality provide the Village with the next year's tipping fee rates annually by mid-November for budgetary considerations.

Whereas the Rural Municipality of De Salaberry (RM) and the Village of St. Pierre-Jolys (Village) entered into a partnership agreement to operate a Class 2 landfill site on July 1, 1987 at the RM owned land at E ½ of NE 14-5-4E, cost sharing the daily operation on a 50/50 ratio, then later modified to 70/30 on March 12, 1996;

Whereas the Village council on February 5, 2010 informed the municipality by letter of their intention to terminate the De Salaberry-St. Pierre-Jolys Landfill Agreement, effective January 1, 2010;

Whereas the RM and Village agreed on March 15, 2010 to set July 1, 2010 as the official partnership agreement dissolution date;

Whereas the Village requested the RM to provide them with a per metric tonne (MT) rate for the Village's garbage deposited in the RM Landfill Site;

Whereas the RM studied the financial operation of the landfill and confirmed that a rate of \$50 per MT be charged to the Village to offset the costs to operate and fund future capital costs of the landfill such as current landfill cell closure costs and new cell excavating and preparation;

Whereas the RM undertook the study of the gate tipping fees schedule and approved a new fee schedule as per Resolution No. 228-10, effective July 1, 2010 with a tiered structure with separate rates for municipal residents who continue to also contribute towards the operations of the landfill site through their property taxes and a second rate for non-residents for ratepayers from the Village;

Whereas the RM was required to review their tipping fee rate schedule to keep up with the increasing environmental regulations and costs required of the RM to maintain a Class 2 Waste Disposal Ground Operating Permit with Manitoba Conservation;

Whereas the Village representatives have made a request to have their residents permitted to dispose of their garbage to the RM Landfill at the same rate as RM residents for at least the balance of 2010 since they are handing over the 30% funded landfill assets such as the Eco-Centre and landfill office;

Whereas the RM has agreed to waive the closing costs of the current Landfill Cell No. 2 where the Village contributed 30% of the garbage for the last 8 years in turn for the Village's 30% funded landfill assets;

Therefore be it resolved that the RM council hereby confirm the Village of St. Pierre-Jolys' residents gate tipping fees as listed in the Resolution No. 228-10 under "Non-resident"

Delegation 7:05 pm Rene Catellier and Marc Maynard for the Gosselin Road Low Pressure Sewer Project

Rene and Marc presented a petition requesting the revival of a dormant project council initiated 3 years ago to extend a low pressure sewer line along the "south shore" of St. Malo Lake. This project was tabled due to lack of interest at the time from the local ratepayers. This proposed line would replace existing septic fields, leaking holding tanks and many unserviced lots. The petition has 49 signatures, not including the Spillway Cove and area subdivision which would bring the number to 67 new service connections.

## Delegation 7:40 p.m. Albert Fillion and Don Bailey Petition against mobile home on St. Charles Road

Albert and Don provided additional information on the petition sent to council from the residents of St. Charles Road with their concerns with the mobile home located at 68 St. Charles Road. The petitioners explain that the offer to purchase that they signed when they bought their lots confirmed that they were not permitted to locate mobile homes. The municipality confirms that no Building Restriction caveats were registered on these parcels and the Zoning By-Law does not restrict mobile homes in any of the zones in the municipality. Albert and Don have concerns with the shape the mobile home is in, the lack of 6 mil poly under the pad, the unsafe railroad ties holding up the trailer, distance setback to property lines, etc. The municipality will have the Building Committee investigate this issue further.
